## Abbreviated Consultation Process Report - Executive Summary (Q1 2019)

#### <u>Purpose</u>

FEMA has allocated 2.4 billion dollars through the Joint Infrastructure Recovery Request (JIRR) for a multi-year road recovery program to the City of New Orleans (CNO) and the Sewerage and Water Board of New Orleans (SWBNO). The Abbreviated Consultation Process (ACP) letter, effective December 17, 2018, and agreed upon by its consulting parties, requires that CNO and SWBNO, together with FEMA, conduct semi-annual consultation meetings throughout the implementation of the JIRR program as part of their reporting requirements outlined in the ACP for adverse effects to archaeology and historic preservation. Since this is the very first report, it was essential to assess all known projects to determine which would require historic preservation and archaeological monitoring. Future semi-annual reports will focus on reporting of statuses as required and listed in the ACP.


#### **Background**

Data for this assessment were collected and assembled in January/February 2019.

The methodology used for this initial report involved mining agency databases, i.e., the Department of Public Works (DPW) DASHBOARD for projects in various phases (waves) that were either located within archaeologically sensitive areas as defined by the Louisiana Division of Archaeology, within historic districts or National Historic Landmarks (NHLs), or NHL-adjacent street segments. Non-FEMA funded projects were also assessed for this report if located within the sensitive archaeological areas or with the potential to affect historic properties. Such effort was to ensure a consistent approach across agencies in the monitoring and reviewing requirements with respect to archaeological resources and historic properties. These results are also contained in the report and labeled "Currently Outside of Scope" under the "JIRR Wave" column header in the fifth row (see page 4).

Using the Louisiana Division of Historic Preservation's "Standing Structures and Districts Map" website, the CNO Historic Preservation Specialist assessed whether a project would impact Character Defining Features (CDFs) within a historic property as defined by FEMA in the ACP, - Appendix 2. Specifically, the Specialist determined which road recovery projects would affect historic properties during a full reconstruction along with actions required by the Specialist for implementation as outlined in the ACP. See ACP Project Details – JIRR Wave 2 (34) Projects, Full Reconstruction Projects on page 8, as an example. Additional projects highlighted include those affecting historic properties designated as NHLs or that were located adjacent to NHLs, for example, Garden Lane next to Longue Vue House and Gardens (NHL). See figures under column heading "Work in National Historic Landmark (NHL) or is NHL Adjacent", page 4.

The CNO Archaeologist weighed each CNO/SWBNO project against the ACP's Appendix 3 map of sensitive archaeological areas and produced a list of projects that would be monitored for archaeological deposits. Some projects that were outside the Appendix 3 map were placed into the monitoring schedule if the CNO archaeologist found evidence that significant archaeological remains may be located or that human remains may be present. These areas include portions of Pontchartrain Park and Filmore South project areas where the prehistoric barrier island complex (Pine Island Beach Trend) may be located. Additional areas of Mid-City's Treme-Lafitte Group B project area were added for monitoring based on the potential for finding humans remains from the lost Bayou St. John Cemetery/Potter's Field. At this point in the process, DPW/SWBNO project managers have been indoctrinated in the process of archaeological monitoring and will help facilitate the implementation of monitoring when the projects begin.



## Abbreviated Consultation Process Report - Executive Summary (Q1 2019)

As of this writing, JIRR projects have been implemented across the city in areas that do not need monitoring or are outside historic districts. Projects that require monitoring in the Mid-City neighborhood have just begun, however, reporting on these projects was not possible for this publication because the CNO archaeologist only arrived on site the week of 3/11/2019. Although outside the JIRR archaeological sensitive area, portions of the Hazard Mitigation Grant Program (HMGP) Hagan-Lafitte project area were added to the docket of areas to be monitored because they were found to be in the vicinity of the Yunmapped indigent city cemetery. When this determination was made by the CNO Archaeologist, he was informed that the project had already begun and he immediately went out and monitored the excavation of St. Peter Street. This hazard mitigation project is one of many projects that were added late to the program after the formal review of the JIRR list. Non-JIRR projects that receive federal funding, such as the HMGP projects, were also assessed in a second iteration of the review process for projects which mixed-sourced funding or had the potential to at least be partially funded through federal funding including by FEMA. To date, the Hagan-Lafitte project has not unearthed any human remains or significant archaeological deposits. We look forward to the Fall 2019 report where archaeological deposits and character defining features can fill the pages of the report.


#### Results in Brief


- Project assessment findings uncovered one-hundred fifty-six (156) total projects encompassed in JIRR Wave 1, Wave 2, Wave 3, and Wave 4. This also includes thirty-five (35) projects currently outside the JIRR scope. Percentage of projects along with number of projects per wave are shown in a pie chart [see "Total Projects (156) by Wave", page 4].
- There were eighty-eight (88) full reconstruction projects broken out by wave as seen on page 4. A total of ninety-seven (97) projects were found in archaeologically sensitive areas. Such projects are also broken down by wave on page 4.
- The "ACP Site Evaluation Chart by JIRR Wave" on page 6 displays a full comparison of project totals and percentages by wave with the number of projects in archaeologically sensitive areas, archaeologically sensitive areas in need of monitoring, number of projects outside the JIRR archaeologically sensitive area still in need of monitoring, and projects requiring cemetery monitoring. This chart also includes comparison totals and percentages for character defining features, work in the NHLs or NHL-adjacent work, the number of projects requiring review of plans for CDFs and full reconstruction projects.
- This assessment noted seventeen (17) projects affecting NHLs along with associated project names and names of historic properties per wave. See page 5 under "National Historic Landmark Sties/Project Details (17 Projects)" for a breakout description along with a pie chart displaying program totals and percentages by wave for NHLs.
- Additional breakouts per wave are also contained in the report and lists further details including project names and names of historic properties as well as percentages and wave totals for NHL-affected properties in pie charts.
