# NOTICE OF CONSTRUCTION

The City of New Orleans Department of Public Works contractor, Impetus Infrastructure, LLC in conjunction with Sewerage and Water Board of New Orleans is continuing work in your area. Crews will complete waterline replacement, drainage upgrades, as well as roadway excavation, asphalt pavement, sidewalk and driveways.

**BEGIN DATE:** Monday, July 8, 2024 at 7:00 a.m.

**END DATE:** Friday, October 30, 2024 at 5:00 p.m. (canvass reminders every 30-days)

In general, crews will work between 7 a.m. – 5 p.m. Monday through Friday.

5000 Wilton – Crews are working to complete asphalt pavement, sidewalks, and driveways 1900 Haik – Crews are working to complete concrete pavement, sidewalks, and driveways 1900 Windsor – Crews are working to complete asphalt pavement, sidewalks, and driveways

### What residents need to do differently?

As this work is being completed, sections of the roadway will be closed to vehicle traffic due to roadway and driveway removal and replacement for repairs. Signage will be posted. **Driveway access will be restored by Friday, October 30, 2024 at 5:30PM.** 

Please move all vehicles off the street before Monday, July 8<sup>th</sup>, 2024 at 7:00AM. **We ask that residents please adhere to no parking signage on the streets. Vehicles parked in these zones will be ticketed and towed.** Additional notice will be given to residents prior to work impacting driveway access.

**U.S. Postal Service and sanitation/recycling** services will continue throughout construction; however, depending on conditions in front of your residence you may be asked to take your garbage and recycling bins to the nearest accessible corner on your normal collection days.

#### **About the Project**

This temporary disruption of services is part of the \$34 M St. Anthony Group A infrastructure project with the City of New Orleans' Department of Public Works and Sewerage and Water Board of New Orleans. The project is focused on repaving the asphalt roadway from curb-to-curb, replacing damaged portions of concrete with new concrete, patching the roadway with asphalt, repairing damaged sidewalks and driveway aprons, installing ADA compliant curb ramps at intersections, and replacing/repairing damaged underground water, sewer and/or drainage lines. The project is scheduled to be completed in Summer of 2025.
